UNDER THE DIRECTION OF ELIZA RUBENSTEIN, THE OCWC HAS RECRUITED OUTSTANDING SINGERS AND CONTINUOUSLY IMPROVED ITS ARTISTRY. AFTER HEARING A PERFORMANCE OF HIS WORK, COMPOSER KIRKE MECHEM PRAISED THE GROUP'S "ALERT AND FLAWLESS MUSICIANSHIP." DUE TO THE PANDEMIC, OUR ENTIRE SEASON WAS MOVED TO DIGITAL ONLINE CONTENT, AND WE HAD NO TICKET REVENUE. OUR REVENUE CONSISTED ONLY OF CONTRIBUTED SUPPORT IN THE YEAR JUST ENDED. WHILE WE TYPICALLY HAVE ABOUT 1,000 PATRONS OVER SIX CONCERTS/THREE PROGRAMS, OUR ONLINE PROGRAMS HAVE ACHIEVED MORE THAN 4,000 INTERACTIONS FROM ALL OVER THE WORLD.
